A warm welcome to Jeff, our guest writer for this week, who has given us a sneak preview of his seminar.

'Not many cases in the law textbooks and insurance manuals are immortalised in a town with a memorial park and monument. However, that's the case when it comes to Donoghue v Stevenson. You'll find them in Paisley, if you happen to be

passing through. In fact, as I have lectured law in various parts of the world over the years, I have come to realise that it's also the only case that is immortalised in the memory of students and insurance professionals. Well, occasionally Rylands v Fletcher also finds a space in the memory, though I'm not aware of a memorial park or monument.

Everyone remembers at least the very basic facts of Donoghue v Stevenson but could it really be that there was no snail in a bottle of ginger beer, or even that May Donoghue was complicit in a 1920s fraudulent claim?

Everyone remembers the neighbourhood principle (some line by line from burning the midnight revision oil) from Lord Atkin's judgment but it couldn't possibly be that Lord Atkin's neighbourhood principle wasn't actually as ground-breaking as the law books lead us to believe, could it?

I appreciate that telling someone who has studied law that all is not what it seems when it comes to Donoghue v Stevenson is like telling someone Santa doesn't really exist. So, I apologise now that I am some sort of modern-day legal Scrooge.

Be prepared, this seminar is likely to raise more questions than it answers as we delve into extracts from the original medical records and pleadings. Every good story also requires some curious characters – we'll learn more about the main protagonists, including the tenacious solicitor who acted for May Donoghue. We'll explore why it might be that Lord Atkin's neighbourhood principle caught the imagination when in fact it wasn't as ground-breaking at the time as some books would have you believe.

Be warned, if you are still in denial after Christmas that Santa doesn't really exist, and you're not ready for more bad news, you may want to cover your ears during this talk. The curious case of the snail in the bottle of ginger beer is about to become even more curious. '
